THERMOPLASTIC TECHNOLOGY IN ARCHITECTURAL RAILING SYSTEMS

Program Presenters: Gina M. Herbert, AVCON®, and Mark Hans, Park and Recreation Products

Our May chapter meeting presentation featured Ms. Gina Herbert of AVCON and Mark Hans of Park and Recreation Products as presenters and dinner hosts. As Vice President of Sales & Marketing with AVCON® for over 10 years, Ms. Herbert has extensive experience in the area of structural railing systems. She is directly responsible for the continuing education of AVCON's representatives as well as architects and design professionals. All AVCON® representatives receive in-depth training on thermoplastic technology, code compliance, and the architectural railing industry.

The main presentation provided an overview the different types of thermoplastic railing systems available and discussed some pitfalls to avoid. Steel railings installed in our climate typically begin to rust within three days of installation. The thermoplastic railing industry touts the benefits of steel core / plastic sheathed railings to this regard. Proper design, detailing, and installation can eliminate the degradation of the railing system from corrosion.

Three types of plastics are used in the marketplace today. These include PVC, ABS, and ASA plastics. Both PVC and ABS plastics

tend to either yellow or gray with prolonged exposure to ultraviolet light. ASA plastic is formulated to withstand the impact of the sun and retains its colorfastness. ASA plastic is also resistant to damage by hundreds of chemicals, and scratches may be removed by simple sanding and polishing.

Like other railing systems, thermoplastic railings can be mounted via the traditional methods of coring, flange, and fascia mounts. It is important to stipulate in your specifications that these types of systems be fully engineered to meet the multitudes of codes that apply to railing systems. Design consideration must be given to expansion and contraction of the plastic, with joints typically spaced at 12 feet on center. The limitations of

this type of product include 1) cannot use as automotive guardrail; 2) cannot be used in extremely ornate designs; 3) costs more in line with powder coated aluminum systems.

AVCON lists several other benefits of its thermoplastic railing systems to include 1) 10 year warranty on color fastness; 2) ease of graffiti removal; 3) ability to match colors; 4) ability to bend, twist, and contort the tubing to meet unique designs; 5) ability to provide fully computerized design and shop drawings for each railing installation; and 6) ability to recycle 100% of the railing system.

Finally, representatives of Park and Recreation Products were at the meeting to discuss AVCON Railings and the other full line of outdoor recreational products. Park and Recreation Products feature a full line of products for athletic field equipment, exterior bleachers and grandstands, manufactured restrooms, press boxes, shelters, sound systems, foul poles and goal lines, and stadium storage equipment. In Memoriam - David L. Bowie, AIA

We were saddened to learn of the death of David L. Bowie, 78, on June 11 in North Charleston, SC after a short illness. David was a Charter Member of AIA Eastern Illinois, President in 1986, and Secretary of AIA Illinois in 1987.

He was born in Cleveland, OH, on February 22, 1932, and received his Bachelor of Architecture - Structural Option from

Rensselaer Polytechnic Institute, Troy, NY in 1954. David served in the United States Navy, seeing Active Duty on the USS Recovery and USS Chickasaw, and Reserve Duty at Joliet, IL from 1960 to 1979, retiring as a Lt. Commander. He was employed at various architectural firms in northeast Illinois, including principal of "The Architects" in Joliet 1974 - 1979; and at Argonne National Laboratory, 1980 - 1995.

After retiring in 1995, David provided specification consulting services and designed residential projects from 1995 to the present.

I met David at one of my first AIA Eastern Illinois Chapter meetings around 1980. When I was working at Interplan Practice, the firm designed projects at Argonne National Laboratory, for which I drafted construction documents with David as

owner's representative. That led to another opportunity some year's later when Architectural Resource Corporation was awarded an indefinite delivery contract for additions and remodelings at Argonne Labs, and as Principal-in-Charge, I worked with David on myriad projects for five years. He was also involved with CSI Northern Illinois Chapter, and taught the CSI certification classes (which Paul Machalek and I attended - see photo). David was a technically-proficient architect, and had a droll sense of humor as illustrated by the following joke that he used for years: Steve: "Hi David, how are you?" Dave: "Almost perfect!"

In Memoriam - Bert Fowler, AIA

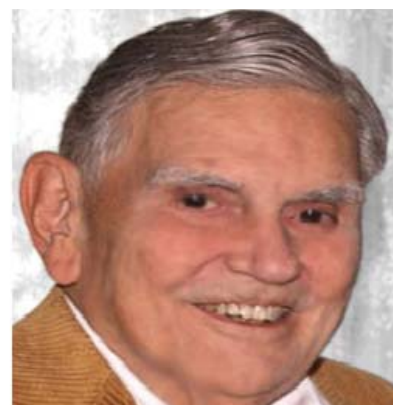
July 11, 1926 - May 19, 2009

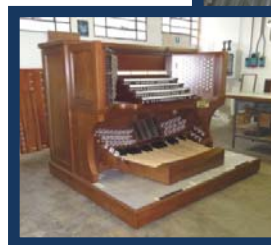

The cross stands 100 feet above ground level, symbolizing the 100-plus years that Olivet has provided an "Education with a Christian Purpose."

With a new pipe organ as the central focus, the chapel seats approximately 3,000 and has a chancel that accommodates 200 musicians. In order to create a feeling of community within this large room, the auditorium is designed to connect the balcony to the main floor.

The 2009-2010 Distinguished Building Awards announcement is included in this newsletter. If you are interested in submitting a building for the AIA/EIC Awards program, complete the announcement form and send it in by July 31. The Distinguished Building Awards packages are due by September 22, the day of the chapter meeting.

Our award juries have commented over the last several awards cycles that some buildings that may be worthy of receiving a Distinguished Building Award were not selected because the awards package that was submitted did not adequately describe the building to the jury.

The Awards Committee requests that if you are submitting a building for consideration for award, please use the same care that was put into the building design to produce an awards package that sells the building to the jury that has limited time and familiarity with your project.

To aid the jury, the Awards Committee has again requested that the submission requirements include a project narrative that is integrated with the visual images that the jury will see. The intent is to provide the jury a more complete package that better tells the building's story. The Awards Committee is not prescribing the

exact method to accomplish this, but some options could include a written narrative that could be read with prompts to advance the images in the PowerPoint presentation or completely integrated PowerPoint presentation that are self narrated. The committee would like to allow the architects the flexibility to best tell the story using the prescribed tools and requirement indicated in the application.

We will again be recognizing the buildings by our members that incorporate sustainable design principles. Please submit your sustainable projects so that we can showcase the forward-thinking work being done by our chapter.

We look forward to receiving submission for all of our members, and hope that the design awards allow the best building to shine.
